**NOTICE OF PUBLIC HEARING

FISCAL YEAR 2026**

NOTICE IS HEREBY GIVEN that the City Council of the City of Bellaire, Texas (City), has called, by Ordinance No. 25-064, a public hearing before the City Council of the City of Bellaire, Texas, to receive written and oral comments on the City's proposed budget for the fiscal year beginning October 1, 2025, and ending September 30, 2026 (i.e., FY 2026). Said hearing is scheduled for Monday, August 11, 2025, at 6:00 p.m., and will be held in the Council Chamber, First Floor of City Hall, 7008 South Rice Avenue, Bellaire, Texas 77401-4411.

The FY 2026 proposed budget document is based on information available to the City at the time the FY 2026 proposed budget document was filed with the City Clerk's Office on Friday, July 18, 2025. The proposed document is available for review by all interested persons in the City Clerk's Office, First Floor of City Hall, 7008 South Rice Avenue, Bellaire, Texas 77401-4411, Monday through Friday, from 8:00 a.m. until 5:00 p.m., except for holidays. A copy is also available for review in the Bellaire City Library, 5111 Jessamine Street, Bellaire, Texas 77401, and on the City's website at www.bellairetx.gov.

This budget is estimated to raise more property taxes than last year's budget by \$378,700.00, an increase of 1.53 percent. Based on taxable value information currently available from the Harris County Appraisal District, it is not possible at this time to determine the amount of this additional property tax revenue to be raised from new property added to the roll this year.
